Following my inspection, I discussed this case with Manager Wasinger regarding the Bear Management Area and Bear Ordinance. I then completed a Bear Management Courtesy Letter and responded back to the property on 12-18-25 at approx 1415 hours and delivered the letter to the female occupant of the home who stated she runs a non-profit organization and asked if that would supersede the bear ordinance.
